

MEMORANDUM OF UNDERSTANDING

Between

International Unani Forum and Scientific Society of Hijamah (Regd.) India

This is an agreement between [IUF] here in after called Party A and [Scientific Society of Hijamah (Regd.) India] here in after called Party B.

WHEREAS, [IUF] desires to engage with Scientific Society of Hijamah (Regd.) India to promote Unani System of Medicine and in particular AYUSH fraternity in general.

WHEREAS, International Unani Forum is also willing to promote research & development, teaching & training programs, publications and professional enhancement of Unani in particular & AYUSH System in general.

NOW, THEREFORE, IUF and Scientific Society of Hijamah (Regd.) India, in consideration of the mutual promises and undertakings here in contained, agree as follows:

PURPOSE AND SCOPE

The desired result is that Unani in particular & AYUSH fraternity in general would take a more active role in public healthcare services, understand for better and manage their ailments, cure them with Unani system of medicine permanently.

Both will also be providing health education, workshops, seminars, conferences, publications to AYUSH fraternity on topics such as Dalk, Fasd, Hijamah Research & Development on Ilaj Bil Ghiza, Ilaj Bil Dawa, Ilaj Bil Tadbeer etc.

IUF & SCIENTIFIC SOCIETY OF HIJAMAH

Shall undertake the following activities in collaboratively.

Provide & supervise the overall policy & program to the members or who will be solely responsible for the instruction, supervision, and guidance of the Unani fraternity whose clinical experience and Research are to occur for the beneficial of humanity.

Both the organization make policy & program with mutual understanding.

IT IS MUTUALLY UNDERSTOOD AND AGREED BY AND BETWEEN THE PARTIES THAT:

1. Mutual Terms and Conditions:

- A. **Terms of Agreement:** The Term of Agreement shall be two (2) year beginning on the Effective Date. Notwithstanding the foregoing, both parties may mutually

agree to terminate this Agreement at any time; and either party may terminate this Agreement by giving written notice of termination to the other party at least ninety (90) days prior to the date of termination specified in such notice.

- B. **No Discrimination:** When carrying out this Agreement, each party agrees not to discriminate on the basis of religion, race, creed, and national or ethnic origin, sex, age, handicap, political affiliation, sexual orientation, disability, status as a veteran.
- C. **Applicable Law:** The laws of Indian Panel shall govern this Agreement. By entering into this Agreement, the parties specifically intend to comply with all applicable laws, rules, and regulations as they may be amended from time to time. In the event that any part of this Agreement is determined to violate rules & laws of state, or local laws, rules, or regulations, the parties agree to negotiate in good faith revisions to the provision or terms as required to bring the entire Agreement into compliance.

EFFECTIVE DATE AND SIGNATURE

This MOU shall be effective upon the signature of authorized officials from Party A and Party B. It shall be in force from 30/11/2021 to 30/11/2023. Parties A and B indicate agreement with this MOU by their signatures below.


